

# AIDS Transmitted By Saliva

Re-visiting the subject of AIDS Transmission by Saliva 34 years after I first got into it, I was not really surprised to discover that the information on the **Centers for Disease Control** web site has not changed. That is their story and they are sticking to it. It shows how a so-called *scientific* establishment often behaves like a government bureaucracy, when that is what it is. They are vulnerable to prevailing political pressure. And locked into a position.

They still admit, as they have from the beginning, that the AIDS virus is found in saliva. In fact, testing for the virus in saliva has become the primary test. And they still have no credible explanation for the assurance that **AIDS cannot be transmitted by saliva**, even though it is found in saliva. They still rely upon pseudo epidemiology arguments to support this assurance. See the earlier documents I produced on this subject.

You might suppose that a few million AIDS cases would have proven something by now. But they never tried to prove their original assumption that AIDS is transmitted by blood and semen, **but NOT by saliva**. Because, if they were wrong, they could not afford to find it out.

It is just as reasonable to assume that **ALL** person to person AIDS cases came via saliva as it is to assume that none of them did. The reasonable assumption is that any body fluid can transmit the virus from one person to another. But, if the AIDS virus can be transmitted by saliva, then **it can be transmitted by CASUAL CONTACT**. That is what they still cannot admit.

On the various web sites which supposedly offer an answer to this question, they put it together with ridiculous questions like: *Can kissing cause pregnancy ?*

One site raises the possibility of someone *spitting in your drink*. You probably don't have any friends who would spit in your drink. But you very likely take a sip of someone else's drink or let them take a sip of yours. Doesn't that produce saliva contact ? And, if one of you has the AIDS virus in his saliva, isn't that likely to spread the virus to the other person ?

Back in September there was a cell phone video posted on line which showed a worker at the Detroit baseball park spitting on a pizza. He was later arrested and ordered to be tested for transmittable diseases. But what about all the other restaurant workers ?

If a person tests positive for hepatitis, he cannot get the card he needs to work in a restaurant. But, if he tests positive for AIDS, it is kept confidential and he can work in a restaurant.

The millions of bath house AIDS cases show that homosexuals have continued to spread AIDS to other homosexuals in a reckless way and even a malicious way, as with *Case Zero* in California.

It is not likely that they would be more careful in spreading AIDS to non homosexuals. And they have a motive for doing it--the more people who catch AIDS, the more pressure there will be on the government to fund the research to find a cure.

All of us want to feel safe from the threat of these deadly diseases. But it often happens that a feeling of safety is an illusion. It seems clear enough--as it was years ago--that the assurance given by the public health authorities is a false assurance generated by political pressure.
